### New-look 'Community Initiatives Fund' opens for applications

Individuals, voluntary organisations and community groups with a vision to boost their local communities and help make Essex a great place to live and work could gain much needed funding from Essex County Council's 'Community Initiatives Fund' (CIF).

Launching on 1 April 2019 the 'new-look' fund brings together a variety of Essex County Council funded community grant schemes under one roof for the first time. The £650,000 fund, which comprises the existing Community Initiatives Fund, Local Service Fund, Local Connections Fund and Cultural Development Grants, will be administered by the Essex Association of Local Councils (EALC) over a two-year period.

Cllr David Finch, Leader of Essex County Council said: "Even in times of extreme financial challenge we want to continue to invest in our local communities. A big thank you to our partners the Essex Association of Local Councils who will administer the scheme on our behalf. I encourage individuals and groups who have a great idea to improve their local communities, and especially those who have not applied before, to make their applications."

Grants of up to £10,000 can be awarded for projects that benefit the wider community and demonstrate a real community need. These may be for new amenities, equipment, new local services or cultural initiatives all of which contribute towards strengthening communities.

In addition, micro-grants of up to £500 are available throughout the year to enable community projects at a grass roots level to quickly and easily access vital funds for projects that can help reduce social isolation, improve wellbeing and support better connected communities.

# New Domestic Abuse Helpline to access Community Based Services and Specialist Accommodation in Essex

A new helpline has been launched to help people in Southend, Essex and Thurrock who are victims of or who have experienced domestic abuse.

COMPASS will go live today, Monday 1 April 2019 and is the new point of access for victims of domestic abuse across Southend, Essex and Thurrock; providing information, advice and guidance and, where appropriate assessment and access to specialist services. Its function is to increase accessibility to ensure victims of domestic abuse get the right support at the right time.

COMPASS is funded by Essex County Council in partnership with the Office of the Police, Fire and Crime Commissioner for Essex to support victims of domestic abuse

across Southend, Essex and Thurrock.

It will help women, men and young people aged over 16 to access specialist support including community-based services and specialist accommodation to help them recover and move on from domestic abuse.

COMPASS will be accessible 24hrs a day. Callers can speak with a trained member of staff and there will also be an online form for both public and professionals wishing to make a referral via the website.

COMPASS is delivered by Southend on Sea Domestic Abuse Projects. The telephone number is 0330 333 7 444. The website is <u>www.essexcompass.org.uk</u>

Community services and specialist accommodation will be delivered by SOS Domestic Abuse Projects, Changing Pathways and Next Chapter. These communitybased services are local hubs incorporating specialist accommodation such as refuges, IDVA (Independent Domestic Violence Advisors) and outreach work.

### 50 groups put their hat in the ring to run community managed libraries

Over 21,000 people responded to the Future of Libraries consultation which closed last month and now groups from all over the county have come forward interested in running community managed library services.

50 expressions of interest have been received so far from a broad range of groups. Two of these proposals are for brand new locations that have never had a library to call their own.

Interest has been received from pre-schools, parish councils, churches, small local businesses, charities, care companies, community groups, those interested in forming a community group as well as the University of the Third Age.

Cabinet member for Corporate and Customer, Cllr Susan Barker said: "We have been delighted with the number and broad range of groups that have come forward with expressions of interest and I am hopeful this number will continue to grow."

### Only a few weeks left to nominate for the Who Will Care Awards 2019

The prestigious Who Will Care? Awards 2019 make a much anticipated return in May, but be quick, nominations close on Friday 12 April.

The date of the 2019 awards has now been confirmed as 22 May and will see a celebration of volunteering across the county.

The awards bring together communities and individuals across Essex who are working to make Essex and even greater place to live, work and visit.

Leader of Essex County Council, Cllr David Finch said: "These awards recognise those that make a real difference to people's lives by giving up their time to help others and their local communities.

"I am delighted that the awards are back for another year. If you know an individual, group or business that deserves to be recognised please nominate them before 12 April. I am looking forward to hearing about all of the people and groups nominated and would like to wish everyone the best of luck."

This year there are nine categories:

- **Business Award:** awarded to commercial organisations who have made an impact on their community.
- Individual Overcoming Adversity Award: awarded to individuals who have demonstrated outstanding commitment within their community either independently or through a charity/community group or through their employer, whilst overcoming personal adversity.
- Individual Volunteer Young Person's Award: awarded to a volunteer under 18 who have demonstrated outstanding commitment within their community. This may be something they have done independently or in connection with a charity or community / youth / school group or employer.
- Individual Volunteer Adult 18+ Award: awarded to a volunteer aged 18+ who have demonstrated outstanding commitment within their community. This may be something they have done independently or in connection with a charity or community / youth / school group or employer.
- Individual Volunteer With a Disability Award: awarded to a volunteer with a disability who has demonstrated outstanding commitment within their community either independently or through a charity/community group or through their employer.
- **Innovation Award:** awarded to social enterprises, commercial organisations and individuals of any age who have demonstrated innovation in developing a service / project to support the community.
- Voluntary Community Service Award: awarded to charities and community groups who are able to demonstrate outstanding service delivery to support their community and / or servicer users.
- Volunteer Team Award: awarded to a group of two or more volunteers of any age who have made an outstanding contribution to their community either independently or with a charity, community group or employer.

• Social Media Volunteer Award: awarded to a volunteer who has demonstrated outstanding commitment within their community through the use of social media. This may be something they have done independently or in connection with a social media group.
